Unless this corporation obtains or already has obtained the appropriate Secondary License from this Commission, this Certificate does not authorize it to undertake business activities requiring a Secondary License from this Commission such as, but not limited to acting as: broker or dealer in securities, government securities eligible dealer (GSED), investment adviser of an investment company, close-end or open-end investment company, investment house, transfer agent, commodity/financial futures exchange/broker/merchant, financing company, pre-need plan issuer, general agent in pre-need plans and time shares/club shares/membership certificates issuers or selling agents thereof. Neither does this Certificate constitute as permit to undertake activities for which other government agencies require a license or permit.

**AMENDED  
ARTICLES OF INCORPORATION  
OF  
PACIFIC UNION INSURANCE COMPANY**

**KNOW ALL MEN BY THESE PRESENTS:**

That we, a majority of whom are residents of the Philippines, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the Philippines.

**AND WE HEREBY CERTIFY:**

First : That the name of the corporation shall be PACIFIC UNION INSURANCE COMPANY.

Second: That the purpose for which the corporation is formed are the following: (Amended on 15 November 1972)

- (a) To carry on and engage in the business of insurance, reinsurance, bonding, fidelity and guaranty in any and all branches except life insurance, and to act as agent of other insurance or surety companies, in any of their branches of insurance including life and to do and perform all such acts and things as may be necessary, expedient or convenient to carry out the purposes intended by the organization of this corporation and not inconsistent with law;
- (b) To lend money on such terms as may seem expedient subject to the requirements of law;
- (c) To purchase or otherwise acquire and undertake all or any part of the business, property and liabilities of any person or company carrying on any business, which this corporation is authorized to carry on or possess property suitable for the purpose of this company;
- (d) To acquire by purchase, subscription or otherwise and to invest in, hold, sell or otherwise dispose of the stocks or bonds or any interest in either or any obligations or evidences of indebtedness or any other corporation or corporations, domestic or foreign, or the bonds or other obligations or evidence of indebtedness of any person, firm or

corporation and while the owner of such stocks, bonds or interest therein, or other obligations or evidences of indebtedness, to exercise all the rights, powers and privileges of ownership, including the right to vote thereon or consent in consent thereof for any and all purposes;

- (e) To guaranty the performance of contracts of all kinds, including the payment of moneys, whether principal or interests;
- (f) To purchase or otherwise acquire, sell or lease, convey, mortgage, encumber and otherwise deal with any property or interest therein, or easement, right or privilege over or in respect of any property, real or personal, as may now or hereafter be permitted by law;
- (g) To do all acts necessary or convenient for carrying or transaction in any foreign country, state, dominion, dependency, colony, protectorate or possession, any business or act of the corporation and to procure the registration or other legal recognition of the corporation in any such foreign country, state, dominion, colony, protectorate or possession;
- (h) To do all such other things as are incidental or conducive to the attainment of the above subjects;
- (i) To do and perform and all of the acts and things and to exercise all of the general powers conferred by law upon corporations similarly organized and usually and ordinarily incidental to the companies of alike nature and kind.

Third: That the place where the principal office of the corporation is to be established or located at Unit 2401 Antel Corporate Centre, 121 Valero St., Salcedo Village, Makati City, or at such place in such town or city as the Board of Directors may in the future decide. (Amended on 08 May 2015).

Fourth: That the term for which said corporation is to exist is fifty-years from 05 June 1995 (Extended on 02 March 1995)

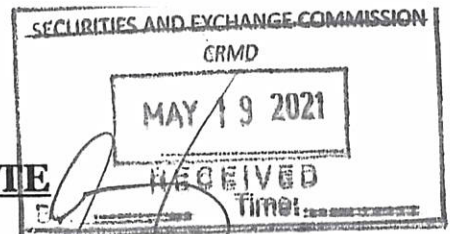
